Proposed Fee Changes for Pattern Approval

As part of its regulatory functions, the National Measurement Institute (NMI) examines and issues pattern approval certificates for the design (pattern) of measuring instruments used for trade and other legal purposes.

It has been determined, based on previous and projected demand, that a 75 per cent fee increase will facilitate cost recovery for maintaining the capability and capacity to examine and certify the patterns of these measuring instruments.

It is proposed to implement the 75 per cent increase in fees proportionally over four financial years.

The first increase of 18.75 per cent will be introduced on 1 July 2019, with subsequent increases introduced as follows:

- 1 July 2020 15.8 per cent
- 1 July 2021 13.6 per cent
- 1 July 2022 12 per cent.

In addition to cost recovery increases outlined above, pattern approval fees will also be subject to annual CPI indexation commencing on 1 July 2020.
